NEW 2019 REGULATIONS The impact of IMSBC Code changes from 1 January 2019 on coal cargoes

On 1 January 2019 amendments to the IMSBC Code will apply. In an article to Gard Club, Penelope Cooke of Brookes Bell LLP, explains the impact of these changes on vessels carrying coal cargoes.

The amendments to the IMSBC Code regard the criteria under which coal cargoes are considered Group A, namely liable to liquefy, in addition to Group B chemical hazards which apply to all coal cargoes. Thus, coal cargoes may need the same TML and moisture certification as other Group A cargoes, such as concentrates, nickel ore and iron ore fines.

The classification of coal has been amended so that it will be treated as both Group A and B, unless otherwise tested. This means that all coal cargoes are to be considered as both liable to liquefy and have a chemical hazard – unless they meet the new criteria as detailed in the IMSBC Code.

In order for shippers to show that a coal cargo is not Group A, they can do it in two ways:

- 1. Coal cargoes will not be subject to Group A requirements if they have a particle size distribution, like: Not more than 10% is less than 1 mm AND not more than 50% is less than 10 mm.
- 2. The relevant authority of the country of loading can specify laboratory criteria to determine if a coal cargo possesses Group A properties. These criteria would be based on the result of the test methods for Group A cargoes in Appendix 2 of the IMSBC Code.

For cargoes that are Group A and B, operators are now able to test the cargo for its Transportable Moisture Limit (TML) using a new test method. This method includes a new procedure on how to deal with lumps over 50 mm in the sample. In this aspect, Ms. Cooke expects that suitable TML test facilities will not be widely available in commercial coal laboratories in the short term.

Moreover, the reason behind the declaration of a cargo as either Group B only, or Group A and B, will need to be clearly stated. The sizing criteria could be included on the cargo declaration, or it could be issued as another certificate. If there are no sizing criteria, the coal should be assumed to be both Group A and B. If the coal has a TML certificate then it must have protection from rain. What is more, the moisture content will need to be re-checked after any rain at the load port.

Finally, other dangers of coal, such as self-heating or methane emissions, still need to be monitored and controlled for each cargo.

EPIRB distress beacons become compulsory on commercial fishing vessels from 1 January in New Zealand

The New Zealand's national regulatory, compliance and response agency for the safety, security and environmental protection of coastal and inland waterways, MaritimeNZ, reminds New Zealand operators that they must install float-free EPIRB distress beacons on commercial fishing vessels by 1 January 2019. The regulation applies to vessels between 7.5 meters and 24 meters operating outside enclosed waters.

Domonic Venz, Maritime NZ's Assistant Compliance Manager for Southern Region, who has an experience on commercial fishing, says float-free EPIRBs really do increase your chances of survival because they call for help when you can't. It's easy to get one on your boat, he says. "Undoubtedly, float-free EPIRBs will save lives. We all know the sea can be an unforgiving mistress: you're a minuscule speck, a needle in the proverbial haystack. You'll be glad that you installed that float-free beacon, which calls for help when you can't".

A float-free auto-activating EPIRB can send a call for help within minutes of being submerged in water, without any action by the crew. Float-free EPIRBs offer significant safety advantages for crew and passengers on vessels in distress.

Compulsory float-free EPIRBs are supported by the industry. The requirement was introduced following the deaths of 24 people over the last 11 years on inshore fishing boats that sank with manual EPIRBs on board that were unable to be deployed.

BMA alerts to the use of new ISO standard safety signs and equipment location markings from January 2019

The Bahamas Maritime Authority has published an alert regarding new escape route signs and equipment location markings. They remind all relevant parties that all new vessels built from the 01 January 2019 should be provided with new ISO standard safety signs as described in Resolution A.1116(30).

All ships built on or after 01 January 2019, and current ships which undergo repairs, changes, modifications and outfitting within the scope of SOLAS Chapters II-2 and/or III, on or after 01 January 2019, will need to make sure that they comply with the signs listed in Tables 1, 2 and 3 in the Annex to A.1116(30).

The resolution includes updated signs and graphical symbols that should be used to mark the location of:

- Means of escape;
- Life-saving systems;
- Mandatory action signs for launching lifesaving equipment.

These need to meet the mandatory requirements of SOLAS regulations II-2/13.7 (ro-ro passenger ship escape routes); III/9 (LSA operating instructions), III/11; (survival craft muster and embarkation arrangements); and III/20.10 (marking of LSA stowage locations).

The Resolution also includes non-mandatory signs for:

- Emergency equipment signs which provide use and location of first aid facilities and safety equipment;
- Fire-fighting equipment signs which provide use and location of firefighting equipment;
- Prohibition signs;
- Hazard warning signs;
- Mandatory action signs which provide mandatory notices and instructions.

In addition, the resolution includes symbols that should be used along with IMO Resolution A.952(23) when preparing the shipboard fire control plans required by SOLAS regulation II-2/15.2.4.

Except from the symbols for 'Safety Plan' and 'Fire and Safety Plan', the symbols are the same as those contained in IMO Resolution A.953(23).
