The past month has been very revealing! I refer to the outcome and findings from the most detailed IIMS membership survey to have been undertaken for four years. The survey findings provide a snapshot into what members think about their organisation, but the verbatim comments - (of which there were dozens and dozens) - reveal far more. Nearly 300 members responded to the survey, equivalent to almost one third of the membership, a high percentage return for a piece of research. So thank you.

A number of these verbatim comments have been captured and published in the Report Magazine September issue, both positive and negative, together with my own personal interpretation of the results. Whilst it is clear that the overwhelming majority of members are generally content with their professional body, there are a few learnings that we can and must take. I am particularly heartened that more than 70% of respondents rank IIMS higher that most or some similar organisations. Specifically, I am concerned that members in Ireland feel let down by a lack of training opportunities and, further afield, those in Australia and New Zealand too. Of course geography plays a key part, but the dormant branches in those two countries have made it more of a challenge to organise activities on the ground recently. However, I am pleased to announce an IIMS event in Sydney, Australia on 2 November. Watch for details. But we must strive to provide the best possible organisation we can for members, no matter where in the world they are.

I had the pleasure of spending some time with members in South East Asia last month when I hosted the eCMID and IIMS seminars in Singapore for the second year. Both days were a success and well attended. Personally I found the range of presentations very apt and of great interest as it seems did those present did too. Travelling to new places gives the opportunity to make new contacts. Report Magazine September published

MCA propose a new code of practice to allow pleasure vessels to be temporarily used for business purposes and as race support boats and is seeking your views

The Maritime and Coastguard Agency (MCA) is seeking feedback on a new code of practice for intended pleasure vessels (IPV).

The MCA would like feedback on a new proposal to allow pleasure craft to be temporarily used for business purposes and has race support boats.

The organisation has been working with British Marine, RYA, and the Yacht Brokers, Designers and Surveyors Association (YBDSA) to develop the new code of practice which is due to be published on 1 January 2019.

The code is divided into parts. The first refers to intended pleasure vessels (IPV) to be used for temporary commercial reasons and the second for said craft to be used to support race boats.

The MCA proposal states: IPV Code – Temporary Commercial Use for Business Purposes

"Part 1 of The IPV Code allows for Intended Pleasure Vessels (boats which are normally Pleasure Vessels) to be in temporary commercial use at sea on a single-voyage basis for business purposes relating to repair, post-production, post-repair or mid-survey sea trials, customer sea trials, or vessel delivery outside the definition of Pleasure Vessel. It is applicable to Intended Pleasure Vessels of any size which are United Kingdom vessels wherever they may be. It also applies to other Intended Pleasure Vessels operating from United Kingdom ports whilst in United Kingdom waters."

IPV Code – Temporary Commercial Use as Race Support Boat

"Part 2 of the IPV Code allows for Intended Pleasure Vessels to be in temporary commercial use at sea on a single-voyage basis as a Race Support Boat for the purpose of Race Support Activities of yacht or powerboat racing affiliated to the National Governing Body of the Sport. It provides a standard for small (<8m) Intended Pleasure Vessels used for no more than ten occasions per calendar year as a Race Support Boat outside the definition of Pleasure Vessel either by the Owner or persons authorised by the Owner to do so. It is aimed at open boats such as Rigid Inflatables but does not prohibit use for small (<8m) decked vessels. Operators of Race Support Boats are advised that other Codes of Practice may be more appropriate for decked vessels."

The MCA is asking owners (individuals or companies) of pleasure vessels to make sure that 'either all use is in accordance with the Pleasure Vessel definition or, if not, then appropriate commercial standards are met' and that if the IPV is used at sea for business or as a race support boat on a temporary basis that owners study the draft new code and have a look at the draft new MGNs.

The MCA also states that owners, brokers, repairers, manufacturers and surveyors who take the craft to sea for business purposes become the operator and in accordance with the code, if the business use is not temporary, that they should seek further advice from the MCA.

The consultation closes at 23:59 on 26 September 2018.

IIMS and BSSA to deliver a second special one day seminar in Amsterdam entitled Marine Corrosion and its Prevention

Following the huge success of the first corrosion seminar delivered by Mike Lewus, British Stainless Steel Association, which attracted nearly 60 delegates in January, IIMS has decided to run the programme again in Amsterdam on 27th November. The day's seminar programme will be delivered at the Park Inn by Radisson near Amsterdam Schiphol Airport commencing at 09.00. Delegates who cannot be there in person may join online live via Zoom.

What will you learn?

- Recap on fundamental corrosion principles including, driving force for electrochemical activity and principles of galvanic corrosion
- An understanding of the corrosion mechanisms that undermine the performance of stainless steel and other 'marine metals' and associated metrics
- An appreciation of what environmental factors influence corrosion above and below the waterline and how this impacts material selection
- Consider how to minimise corrosion through material selection, improved design and other strategies i.e. cathodic protection, changing electrode potential, surface treatments etc.
- Become familiar with important aspects of failure analysis; inspection, sample preparation, analytical techniques and diagnostic methodologies

The day's course will be delivered in six modular sections as follows:

- 1) Corrosion: Fundamental Principles
- 2) Forms of corrosion in 'marine metals'
- 3) Corrosion above the waterline
- 4) Corrosion below the waterline
- 5) Corrosion prevention strategies
- 6) Failure analysis and case studies

Report on IIMS and eCMID seminars in Singapore

For the second consecutive year, IIMS organised and hosted a three day event in Singapore. IIMS is grateful to Simon Ward of MatthewsDaniel for their generous support of the event, which attracted good numbers over the three days.

The first day saw nearly 20 delegates attend a one day eCMID AVI accreditation validation course under the tutelage of Joe McWilliam.

Day two was aimed directly at those involved in the inspection of offshore assets using the eCMID format.




Mike Schwarz welcomed guests and gave an overview of the accreditation scheme so far. Joe McWilliam spoke about the key learnings from more than 30 AVI courses so far. There followed a video presentation of Mark Ford (and IMCA colleagues) addressing the seminar in April as he talked about eCMID updates. Alex Harrison, LOC Group Director for Energy Services, closed the morning session with his thoughts on offshore wind farms and marine warranty surveying. After lunch, Joe McWilliam picked up the reins and talked about risk, the mariner and eCMID. He was follows by Simon Ward, Regional MD of MatthewsDaniel, who talked about the relevant subject of reactivation inspections and surveys and why they matter in a part of the world that has seen hundreds of lay-ups. The day concluded with Alex Brabin from M3 Marine speaking about the reactivation of DP vessels as he touched on a proposed new DP accreditation scheme under review by IMCA.

Seminar day two dawned. Once again Mike welcomed guests and following a short introduction by President, Capt Zarir Irani, gave a comprehensive overview of the many activities that IIMS is currently involved in. Zarir spoke knowledgably on the subject of shortage and misdeclaration claims and warned surveyors what they should be looking for and gave some of the reasons why claims are inaccurate. Mike Meade, CEO of M3 Marine, talked about the disruptive technologies facing surveyors, particularly with the onslaught of drones.

Following the lunch break, Simon Ward gave an in-depth insight into the common issues associated with operating and towing MODUs. He gave some rather sobering case studies to remind marine warranty surveyors and surveyors in general of the many dangers that are lurking. Jason Wee, Claims Director for Standard P&I Club Asia, delivered a thought-provoking presentation about what the club expects from a surveyor carrying out P&I Club work. Chad Fuhrmann from Maritime Assurance & Consulting Ltd closed the event with a powerfully delivered presentation about rebuilding confidence in reactivated assets, what to look for and how to deliver it.
