

CEO Chat

Dear Member

Regulation changes are afoot again it seems as we start to approach the end of the year. In reality they are never far away as the sector is forever changing to meet the evolving needs of the modern boating and shipping world, albeit generally behind the curve in my opinion rather than ahead of it. Work is now well underway by the Maritime and Coastguard Agency (MCA) in the UK to update the "colour codes" that are used by coding examiners on vessels under 24 metres in commercial use. Presentations have been given to the UK based Certifying Authorities in recent weeks and a roll out of the first phase is not too far away I suspect. The codes are long overdue for a refresh, and this is to welcomed when the current codes, those which are already Statutory Instruments, are finally updated. In my role as Chair of the Certifying Authority Professional Standards Working Group, I have a special interest in seeing what the outcome is.

The other significant looming regulation change is the IMO 2020 Sulphur Cap which is set to hit the shipping sector and to be enforced from January. Disruptive change for the industry for sure, the word on the street amongst those in the know is that many ship and vessel owners/operators are struggling to be ready to meet the new regulations for a variety of reasons. The new regulation will see marine sector emissions in international waters slashed. The marine sector will have to reduce sulphur emissions by over 80% by switching to lower sulphur fuels. Clearly this is a challenge and not without significant cost for some, so it will be interesting to see how Flag States react in their local waters to non-compliant vessels from January. Are we likely to see many ships detained in ports around the world? Only time will tell.

New web version of the IIMS Marine Surveyor Search App to be added

eDot Solutions, the Institute's App partner based in Goa, is developing a web-based version of the recently launched Marine Surveyor Search App for those who prefer not to use the applications for iOS and Android devices, which is due for roll out imminently. Final changes and tweaks are being made.

The web version works in a very similar way to the smart phone applications with identical content and will, in time, replace the existing IIMS website search for a surveyor. Web users may use this version to perform a surveyor search and communicate with their chosen person without the need to register but will not have full access to all the App functions. Only by registering will they have complete access to features such as my favourite surveyors, recently viewed surveyors and so on.

The content is drawn from the current IIMS practicing surveyor membership database, which has been loaded in its entirety into the App - some 800 surveyors in over 100 countries worldwide.



Many members have yet to check their listing on the App for accuracy and to ensure it is displaying as you would like it to show with the correct details and so on. So, if downloading the App has been putting you off from doing this, look out for how to do this via the web coming very soon.

Yacht and small craft surveyors will be interested to know that they are now also able to show on their listing which harbours and marinas they operate in and this will be searchable by the user. However, if you want to add new location you will need to let HQ know please.

Report Writing Online Seminar and Tutorial



Before you reserve your place, please note this online seminar will be broadcast at 12.00 UK London time on 24 October 2019 using the zoom video conferencing platform and will last for 3 hours approximately. The seminar is open to IIMS members and non-members.

Your hosts and presenters for this seminar are Paul Homer, IIMS Chairman of Standards and Mike Schwarz, IIMS Chief Executive Officer.

IIMS receives too many surveyor complaints each year, generally caused by poor writing standards and skills, some of which are serious in nature. And the situation is not improving. A report is the surveyor's intellectual property and he/she lives or dies by it. This maximum three-hour online course, featuring a lot of new content bringing the art of report writing bang up to date, aims to provide the essential information that a yacht and small craft surveyor needs to consider when gathering the information and then compiling his/her report. There are suggested clauses for use in the report to protect against possible litigation and advice in the event that something goes wrong. Additionally, there is advice on contracts and terms of business and how, when and where these should be used. There is also, for the first time, a practical session and delegates will be required to do a little preparation before the seminar in readiness and encouraged to contribute their thoughts. So, if you want to tidy up and strengthen your report writing skills this is a good place to start.


