

CEO Chat

Dear Colleague

There is a lot to digest in this month's expanded news bulletin.

I would urge all surveyors to read and to take note of the contents of an open letter from IIMS President, Geoff Waddington. It concerns a lack of attention to professional procedures, which is concerning and, having now come to light, is getting some members into hot water. On a lighter note, Geoff came to Portchester to cut the ribbon to officially open Murrills House as our new HQ in a socially distanced ceremony - photos are shown in this bulletin.

The September Report Magazine, edition 93, has been published today. It is another monster publication, extending to 112 pages, another record-breaker containing a great selection of news and relevant articles. I have authored the lead feature article having become fascinated by the onslaught of remote surveys in recent months. The article

positive experience for all and plan to work with each member to ensure that the specialisations shown on each current listing are accurate and to understand if new ones should be added. The rationale behind this development is explained in more detail inside this bulletin.

Whilst touching on the subject of surveyor specialisations, the much vaunted and eagerly anticipated Accredited Marine Surveying Practitioner scheme that has been under development for some time is advancing well. To complete the project in readiness for launch, we are looking for specialists to join the assessor panel, individuals who can review

applications with the very same specialisms as themselves to ensure competency. Please have a read about who we are seeking in the bulletin and put your name forward to be considered.

If 'heavy' committee work is your thing, IIMS is looking for a member to represent the Institute at future British Standards Institute (BSI) committee meetings following the retirement of Peter Morgan. 

Professional Procedures - an open letter from IIMS President, Mr Geoff Waddington



"Dear Member,

It has come to my attention (as well as to the Institute) that proper professional procedures are not being followed by some members.

For guidance and for your protection against litigation the survey procedure should follow these basic but essential guidelines.

1. Enquiry: The initial enquiry if by phone call should be re-directed to email so that a record can be kept in the boat's file.
2. Quotation: A written quotation including the scope of survey and survey limitations should be sent to the instructing client.
3. Acceptance of quotation: This should be in the form of an email from the instructing client stating the level of survey required.
4. Letter of Instruction (The Survey Contract): Once the acceptance of your quotation for a particular level of survey has been received this should generate a letter of instruction which must include the surveyor's standard terms and conditions.
 - The letter must state the level and specific type of survey for which you are being instructed.
 - The letter must have a statement regarding permission from the owner granting access to conduct the survey.
 - The letter requires the address of the instructing client (for future invoicing) and contact details of the owner and or broker.
 - The letter must quote and confirm the agreed cost of survey.
 - The letter must be signed by the instructing client.
 - Terms and Conditions must be attached or available to view somewhere.
5. On completion of the survey any additional and unforeseen expenses in regard to the survey need to be agreed with the instructing client.
6. An initial draft report should be produced requesting comments and corrections from the instructing client.
7. At this time an invoice should be sent to the instructing client (circumstances may dictate whether payment is required in advance of the draft report or even before the survey itself and will have been stipulated and agreed).
8. On receipt of payment a signed and dated final copy of the report should be produced and sent to the instructing client.


If you are not currently following these procedures, you are leaving yourself wide open to potential litigation and may find yourself exposed. IIMS members, please take note and heed this sound advice."

Cancellation of remaining IIMS face to face events

With the pandemic continuing to strengthen its hold on the world, IIMS has taken the only decision it can, which is to cancel all remaining face to face events planned for 2020. That means no live events in Malta, Dublin, Scotland and the south of England this autumn.

The spread of COVID-19 also means that the 10th Anniversary plans that the IIMS India Branch Committee had in place for November 2020 have been put on hold and the event will not take place this year. They are looking at the possibility of shifting the event back to the latter part of 2021.

The annual IIMS US Conference held in Baltimore in January each year has also been cancelled to be replaced by an online only event in 2021. The schedule is being finalised and will be released soon.

IIMS is now working hard to put together Marine Surveying Fest III, two days of online celebrations of marine surveying with plenty of knowledge presented by experts to be shared with attendees, either in real time or on catch up video. Watch for the schedules to be released soon, but the dates for your diary are Monday 30th November (yacht and small craft surveyors) and Wednesday 2nd December (cargo and commercial ship surveyors).



Are you interested in becoming an assessor for the new Marine Surveying Practitioner accreditation scheme?

The soon to be launched Marine Surveying Practitioner (MSP) scheme, to be powered by IIMS and the Marine Surveying Academy, has been under development for some considerable time, but is nearing completion. The pandemic has slowed up the process. But the team of assessors who will underpin the integrity of the scheme is soon to be assembled and we need your help. Would you like to be an assessor in your own particular area(s) of surveying, reviewing the applications of others who believe they share the same depth of knowledge as you do in your specialism? If so, please step forward and put your name up for consideration.

This new initiative to create a minimum acceptable worldwide standard for marine surveying is a bold, but long overdue one. It is not a quick fix to a worldwide problem and will take time to build, but the long term aim is to recognize the competency of those who really 'know their stuff' and to make it harder for those who don't with the result being enhanced safety of life at sea and on water. Its success will be ultimately determined by accurately reviewing and confirming the specialisms that are being claimed by surveyors, backed by the supply of objective evidence, which meet the requirements of the scheme and the individual assessor.

At this stage, there are currently:

- Yacht & Small Craft Surveyors (up to 24 metres) - 6 material types and 35 specialisms available to apply for.
- Superyacht Surveyors (over 24 metres) - 5 material types and 12 specialisms available to apply for.
- Cargo & Commercial Ship Surveyors - 30 cargo surveying specialisms and 47 other commercial surveying specialisms available to apply for.

IIMS announces the results of a review and major overhaul of surveyor specialisations

The Institute's Professional Assessment Committee (PAC) is made up of a group of the most senior and experienced surveyors from all walks of the profession and is drawn from the IIMS membership worldwide. It is the role of the PAC to maintain standards of membership at the highest possible level and to ensure that IIMS applicants are granted levels of membership and website listings that reflect their actual marine surveying experience.

However, IIMS has a legacy issue that it needs to face up to. Some members have had the same specialisations attached to their profile for many years, in several cases for nearly 30 years. To say an individual's specialisations are long overdue for a review would be something of an understatement, which could also be said for the list of specialisations themselves too!

The PAC met recently to review the existing lists of surveyor specialisations with a view to expanding the list to reflect the actual types of surveys carried out by marine surveyors. An example of the changes made is that the original three basic areas of cargo surveying - Breakbulk, Dry Bulk and Bulk Oil/Chemicals - have now been expanded to cover eleven specialisations that will give a more accurate description of a surveyor's experience.

Standards for entry are more precise now than they were many years ago and this has brought into question some of the current IIMS website listings held by existing members. This process of review can only be a good thing and adds further credibility to IIMS as an international organisation. New membership applicants need to show

objective evidence and details of experience relevant to their specialisation if they are to satisfy the PAC these days. Of course, new specialisations have emerged over

recent times and IIMS is keen to reflect this with an expanded list.

What has certainly become apparent and pointed out is that there are a number of commercial ship surveyors claiming to have a range of skills enabling them to also survey a small 10 metre yacht and vice versa. Whilst a few such people do exist, they are rare and surely we all know that too?

Having reviewed the list of specialisations at their recent meeting in some detail, the PAC has agreed two new lists (one for commercial ship and the other for yacht and small craft surveyors) that are printed here and which will come into force imminently.



Chief Executive Officer, Mike Schwarz, commented, "The review of members' surveying experience listings is long overdue and is a large, yet essential project likely to take many months to complete. I am delighted to see some new specialisations on the list, such as MCA coding examiner and guard vessels to name but two. We plan to work with each and every member in the coming period to ensure their specialisations are up to date and accurate."

Where it is obvious, IIMS will transfer a member's existing specialisation to one of the new ones, (if necessary). It is a fact that members who joined years' ago may well no longer perform the functions they did and were approved to do then but will have developed new skills not showing on their profiles. Please check your listing and make sure it actively reflects the work you do and the marine surveying activities you are competent to undertake. There is no cost for amending your listing, but evidence will be required if you want to add new ones.

PAC Chairman, Capt Chris Kelly, summed it up very well when he said, "Ultimately, it is about the IIMS accurately reflecting the substantiated marine surveying experience of the membership and promoting this experience to the wider marine world through the IIMS website and the Marine Surveyor search App."

IIMS President formally opens the new Institute's flagship headquarters



It is described as 'heavy committee' work, so if this is not your skill set, move on.

About BSI

'Our purpose is to inspire trust for a more resilient world. Our solutions and services improve performance and support the United Nations Sustainable Development Goals. At BSI, our mission is to share knowledge, innovation and best practice to help people and organizations make excellence a habit. This is underpinned by our role as the national standards body and through our prestigious Royal Charter'.

What are standards?

Standards define best practice in many different areas. They are put together by groups of experts and come in a number of different kinds, from a set of definitions to a series of strict rules.

Standards are agreed ways of doing something, written down as a set of precise criteria so they can be used as rules, guidelines or definitions.

This is the situation the BSI committee wants to avoid:

'What bloody idiot wrote that? There is no way I can survey that as intended'.

And this is the desired outcome that BSI seeks:

'This is a meaningful standard that helps manufacturers meet the regulations and is easy to survey and certificate during build and operation so that the owner can be confident in its performance'.

Members of the BSI committee attend and mirror regulatory developments at IMO in real time and horizon scanning. As new regulations develop the committee assists ISO in developing the implementation tools that provide the link between the regulation and the operation. The BSI committee does most of the items that Class Societies do not do and, ultimately this can assist with keeping IIMS members up to date and understanding how new developments may influence them in the future.

ISO mainly develops manufacturing standards, but also systems and inspection standards. The ability to understand how a product can be built to be surveyed, from a life raft to a yacht to an oil tanker, is a very important perspective during the development of standards. And of course, if that element is not represented during standards development, the end result is an item that cannot effectively be surveyed during manufacture and operation.

The BSI Committee aims to meet two or three times a year and alternates between London and Southampton to facilitate MCA attendance. One presumes this is all online currently.

This is not a paid role, but IIMS understands any out of pocket expenses incurred in performing the role will be met.
